Key points

There is no joining fee. A £22 union levy is added to applicable categories. Junior memberships have no additional levies. Membership is a 12-month rolling agreement from the 1st of the month membership starts.

Membership conditions

- 1 Select the membership category required on page 1.
- 2 Five Day Membership covers Monday to Friday. Weekend golf must be supplemented by a visitor fee.
- 3 As per the Club Constitution, Five Day Members have no vote in the running affairs of the club.
- 4 Membership renews automatically each year unless written notice is received at least 2 months before renewal.
- 5 Once a new year has begun, the member is liable for all fees due for that full year unless the required 2 months notice has been given.

Payment schemes

- 1 **Payment options:** Membership can be paid in full or by Direct Debit over 12 months.
- 2 **Direct Debit exclusions:** Flexible, Social and Junior Memberships must be paid in full.
- 3 **New members:** Fees must be paid in full before membership starts unless paying by Direct Debit.
- 4 **Direct Debit set-up:** 1 x 3-month payment is paid directly to the club on joining. The following 9 payments are collected by Direct Debit from the 1st of the following month, keeping the account 3 months in advance for the first year.
- 5 **Mandate:** A Direct Debit mandate must be completed on application when choosing to pay by Direct Debit.

Direct Debit rules

- Direct Debits can be set up on all membership categories other than Flexible, Junior or Social Membership.
- Direct Debit payments incur a £1.50 monthly administration charge.
- Membership is taken out for 1 full year and must be paid in full. This is a minimum 1-year agreement/contract.
- Cancelling a Direct Debit does not cancel the balance due. Missed Direct Debits must be paid in full before the start of the following month. Membership will be suspended if unpaid and the balance remains due.
- Membership renews automatically each year unless 2 months written notice is given that it is not being renewed.

Existing members

Annual bills should be paid in full at least 2 weeks before the renewal date. If changing from annual payment to Direct Debit, all payments that would have been due under the Direct Debit scheme for that category and renewal date must be paid before the Direct Debit is set up, keeping payments in line with other members.

Note on handicaps

A handicap allows members to enter club competitions and medals, plus other club competitions that usually offer excellent value compared with buying one-off rounds. Details on obtaining a handicap are available from the Club Professional or Match Secretary.
